Re-Invitation for Bids for the Construction of Office Building of Geruwa Rural Municipality Contract Identification No. <u>W/GRM/NCB/04-1/2075-076</u>

- 1. The Geruwa Rural Municipality [GRM] has allocated funds towards the cost of Construction of Office Building of Geruwa Rural Municipality and intends to apply part of the funds to cover eligible payments under the Contracts for Construction of Office Building of Geruwa Rural Municipality (Contract No: W/GRM/NCB/04-1/2075-076). Bidding is open to all eligible bidders as per Section V of Bidding Document.
- Geruwa Rural Municipality invites electronic bids from eligible bidders for the construction of office building of Geruwa Rural Municipality under National Competitive Bidding-Single Stage Two Envelope Bidding procedures.
 Only eligible bidders with the following key qualifications should participate in this bidding.

Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
- 4. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of Geruwa Rural Municipality, Bardiya, Nepal or may visit PPMO e-GP system www.bolpatra.gov.np/egp.
- 5. Bidder have to submit their bid electronically and can download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the Office's Rajaswa (revenue) account as specified below Information to deposit the cost of bidding document in Bank:

- 6. Pre-bid meeting shall be held at Geruwa Rural Municipality, Bardiya, Nepal at 09-04-2019 13:00 hours.
- Electronic bids must be submitted to the office Geruwa Rural Municipality, Bardiya, Nepal through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 18-04-2019 12:00. Bids received after this deadline will be rejected.
- 8. The bids will be opened in the presence of Bidders' representatives who choose to attend at **18-04-2019 14:00** hours at the office of Geruwa Rural Municipality, Bardiya, Nepal. Bids must be valid for a period of 120 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of ebid, amounting to a minimum of NRs. 1510000 which shall be valid for 30 days beyond the validity period of the bid.
- 9. If the last date of submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
